Background:

The National Languages Equality Advancement Project (NLEAP) aims to reduce poverty and improve economic and social equality of Sinhala and Tamil speaking women and men throughout Sri Lanka by strengthening the implementation of the Sri Lankan Official Languages Policy (OLP) and enhancing acceptance by Sri Lankan women and men of cultural diversity in the country.

Working with the Government of Sri Lanka (GoSL) and civil society organizations, the project strengthens gender-sensitive bilingual communication skills of public servants; improves the capacity of key ministries to deliver public services in both official languages (Sinhala and Tamil) at national and provincial levels, especially in bilingual communities; increases awareness of language diversity and language rights; and increases the ability of citizens to communicate in the official languages.

NLEAP is funded by the Government of Canada and implemented by Alinea International. NLEAP is designed to respond to the GoSL's goal to protect and promote the language rights of all its citizens and support and strengthen the OLP implementation with the Ministry of Public Administration, Home Affairs, Provincial Councils and Local Government and its affiliated institutions. These institutions include the Department of Official Languages (DOL), the Official Languages Commission (OLC), and the National Institute of Language Education and Training (NILET). NLEAP also supports selected universities through the University Grants Commission (UGC) and provides grants under the National Languages Fund (NLF) to support civil society organizations in the promotion of language rights and second language learning.

The Position:

Based in Colombo, Sri Lanka, the Local Capacity Development and Governance Specialist will report directly to the Project Director. This position will require travel within Sri Lanka.

Specific responsibilities include:

- Facilitate coordination and collaborative work among short-term technical experts in the
 delivery of technical assistance to improve the enforcement and promotion capacity of the
 Official Languages Commission, improve the capacity of civil society to monitor and promote
 the implementation of the policy, language societies and consultative forums.
- 2. Coordinate the implementation of activities, including training, involving the diversity and non-language communications manuals at the National Languages Division (NLD) and NILET.

- 3. Works closely with the Project Director and other specialists in the planning and implementation of the national local government capacity development activities.
- 4. Works closely with the Project Director and Project Deputy Director to support National Language Fund projects, including proposal evaluations and review of progress reports.
- 5. Provide technical expertise to maximize the results from training, mentoring, coaching and peer-to-peer activities.
- 6. Integrate governance principles into project implementation, including: the use and promotion of participatory and inclusive processes; the promotion of transparency, accountability, and oversight mechanisms; awareness raising of government and non-governmental actors regarding their respective roles in language policy implementation; and ensuring that access and provision of services are non-discriminatory.
- 7. Coordinate with other project advisors and specialists to integrate cross-cutting themes, (gender equality, environment, and governance) throughout the project.
- 8. Maintain up-to-date knowledge of current initiatives by national and international partners to identify synergies and benefit from lessons learned.
- 9. Maintain open communications with local stakeholders, project partners and staff
- 10. Provide inputs in the development of the Work Plans.
